The four Rs of a trauma-informed approach

- REALIZE the widespread impact of trauma
- RECOGNIZE the signs and symptoms of trauma
- RESPOND by fully integrating knowledge about trauma into policies, procedures, and practices; and
- RESIST RE-TRAUMATIZATION
